Township Annual Meeting

Tuesday, March 9, 2021

Minutes

The 2021 Princeton Township Annual Meeting was called to order by Township Clerk Doug Dahl at 8:25 p.m. Due to the Governor's COVID19 meeting restrictions the meeting was conducted remotely via Zoom.

Clerk Dahl welcomed the participants, then explained the Town Board's reasons for conducting the meeting remotely. The Board had concluded that holding the meeting in person under current restrictions would not be advisable. However, the Board also recognized that the prevailing sentiment among township residents was to conduct the meeting in person. To achieve that end, Clerk Dahl contacted Princeton Community Education to inquire about the availability of Princeton Middle School. The coordinator said he could reserve a room for the township after all school activities had concluded for the year. Mr. Dahl then reserved the Princeton Middle School cafeteria for Tuesday, June 22, 2021 at 7:00 p.m.

Eugene Stoeckel moved to continue the Annual Meeting to June 22, 7:00 p.m., at Princeton Middle School. Seconded by Joel Minks. Motion carried 19-0.
