## **Public Hearing**

Commission Chairman Dave Persing opened the public hearing at 6:00 p.m.

The Purpose of the hearing was to consider a request by Debra and Dustin Hoffman for a Conditional Use Permit to allow a second single family homestead at 1474 Alpha Road/County Road 1.

Scott Richards reviewed the application. The second dwelling would allow grandparents to live on property close to family. The building would be 30x50(1,500) square foot structure with a two-bedroom living quarters. The property is zoned Residential R2 District in which a second single family dwelling is allowed for a homestead with issuance of a Conditional Use Permit.

No one from the public wanted to speak.

Commission Chairman Dave Persing closed the public hearing at 6:04 p.m.

### **Public Hearing**

Commission Chairman Dave Persing opened the public hearing at 6:05.

The Purpose of this hearing is to consider Noise regulations in section 700:240-Addition of Reference to Minnesota Administrative Rules.

Scott Richards gave the background on the recent noise complaints in the Township Township's noise ordinance and suggested the Township include reference to Minnesota Administrative rules related to noise limitations throughout the state. These regulations are in place statewide and can be enforced even if the Township does not have the reference in its code. Staff would recommend adding a reference so that a person seeking guidance on noise regulations in the Zoning Ordinance will be aware of the state rules.

## **Public Forum**

Jim Goestch spoke about the noise coming from the neighbors and concerns the Sheriffs Department won't do anything.

Joel Minks said it was discussed at length at the last Town board meeting. He wanted to put the reference to the state rules in the ordinance.

Jeff Smith lives eighth of a mile from said resident in the noise complaint. He played a video to demonstrate the noise level. He was concerned about the multiple campers on the property.

A letter from Tina Bolda was read in support of the amendment to add the State rule verbiage.

Commission Chair Dave Persing closed the public hearing at 6:13.
