Open Forum

- Curtis Strombeck: He wanted to let the Board know he had spoken with the current owners of the Abney Recycling property. They are not aware of the current property that the Township is rezoning. They had asked for 3 houses on their current property and were denied. He would like to know why the Township would deny them but approve a builder who lives out of state. He would like to see the Township Board represent the people more than developer.
- Joseph: He would like to know when the ditch will be getting cleaned up. He stated that this project has been going on for 3 years, and he would like an update.
 - Supervisor Whitcomb explained that they are waiting for the contractor and that they will be looking to do the work in the summer months.
- Brett Cloutier: He is a current teacher in the Princeton Schools. He is a father of a young family and would like to move his family into the Township. He would love to raise his kids in the community. He would like a 1.5-acre lot as it is not too much keep up with, yet it is enough to have their privacy.
- Eric Jacobs: He is in favor of this because he also has a growing family, and he would like to have a home in the Township. He explained that this lot size is perfect for his family.
- Tom: He is not happy that the developer sent out unsigned letters with unclear information. He reminded the Board that the developer is not from Princeton, let alone MN. He doesn't think families will like when Moonshine Bar has events in the backyards.
- Mellissa Griswold: She reminded the Board that she is on a smaller lot and after 3 years has outgrown it. She would also like Board to approve her Variance for her property.
- Matt Akerson: He wanted to share the county road and other roads in this area are not ready for more traffic. He stated that this will start with 60 new homes, but over time it will be 80 to 90. He feels 1.5 acre lots are a great starting point for some, but in that same breath many families do outgrow smaller lots and will want to have larger lots later in time. He would not like the City of Princeton any closer to the Township.
- Natalie McConnell: She is excited to hear about the chance to build in the Township. She feels that this is going to help the community grow, allowing families to stay in the area.
- Kristie Bernard: She would like the Board to look at this as an opportunity. She is a real estate agent and knows that there are people who would like homes in the area. She also believes that this area is perfect for development because the land does not yield enough crop growth and there is small mount of area that is tillable without cutting trees down.
- Dave Persing: He is looking to build a greenhouse on his property and has reached out to the building officials and has not heard anything. He has been waiting about 2 weeks for a reply and has not gotten one yet.
 - Scott agreed with Mr. Persing that he meets the requirements for the greenhouse,

but he would also like to have the building inspectors look at the plans before going forward. Scott will reach out for an update.
